**संख्या मुद्रण (बी ) 10 -53/2010.**—हिमाचल प्रदेश की राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हिमाचल प्रदेश लोक सेवा आयोग के परामर्श से, समसंख्यक अधिसूचना तारीख 29-12-2012 द्वारा अधिसूचित हिमाचल प्रदेश मुद्रण एवं लेखन सामग्री विभाग, सहायक अनुभागपाल, (अक्षरयोजन), वर्ग-III (अराजपत्रित) अलिपिक वर्गीय सेवाएं, भर्ती और प्रोन्नति नियम, 2012 का और संशोधन करने के लिए निम्नलिखित नियम बनाती हैं, अर्थात्:-

1. **संक्षिप्त नाम और प्रारम्भ.**—(1) इन नियमों का संक्षिप्त नाम हिमाचल प्रदेश मुद्रण एवं लेखन सामग्री विभाग, सहायक अनुभागपाल, (अक्षरयोजन), वर्ग-III (अराजपत्रित) अलिपिक वर्गीय सेवाएं, भर्ती और प्रोन्नति, (प्रथम संशोधन) नियम, 2014 हैं।

(2) ये नियम राजपत्र हिमाचल प्रदेश में प्रकाशित किए जाने की तारीख से प्रवृत्त होंगे।

2. **उपाबन्ध "क" का संशोधन.**—हिमाचल प्रदेश मुद्रण एवं लेखन सामग्री विभाग सहायक अनुभागपाल, (अक्षरयोजन), वर्ग-III (अराजपत्रित) अलिपिक वर्गीय सेवाएं, भर्ती और प्रोन्नति नियम, 2012 (जिन्हें इसमें इसके पश्चात् "उक्त" नियम कहा गया है) के उपाबन्ध 'क' में :—

(i) स्तम्भ संख्या 7 के सामने विद्यमान उपबन्धों में "सरकारी मुद्रणालय/आई0एस0ओ0" शब्दों और चिन्ह के स्थान पर, "सरकारी मुद्रणालय/भारतीय मानक संगठन" शब्द और चिन्ह रखे जाएंगे।

(ii) "उक्त" नियमों के स्तम्भ संख्या 15-क

(VII)(ड) के सामने विद्यमान उपबन्धों के स्थान पर निम्नलिखित रखा जाएगा, अर्थात् :-

"संविदा के आधार पर नियुक्त कर्मचारी, जिसने तैनाती के एक स्थान पर तीन वर्ष का कार्यकाल पूर्ण कर लिया है, आवश्यकता के आधार पर स्थानान्तरण हेतु पात्र होगा, जहां भी प्रशासनिक आधार पर ऐसा करना अपेक्षित हो।"

3. **उपाबन्ध "ख" का संशोधन.**—उक्त नियमों के उपाबन्ध 'ख' में विद्यमान निबन्धन और शर्तें संख्या 6 के स्थान पर निम्नलिखित रखा जाएगा, अर्थात् :-

"संविदा के आधार पर नियुक्त कर्मचारी, जिसने तैनाती के एक स्थान पर तीन वर्ष का कार्यकाल पूर्ण कर लिया है, आवश्यकता के आधार पर स्थानान्तरण हेतु पात्र होगा, जहां भी प्रशासनिक आधार पर ऐसा करना अपेक्षित हो।"

Public Service Commission is pleased to make the following rules further to amend the Himachal Pradesh Printing and Stationery Department **Assistant Section Holder (Composing), Class-III** (Non-Gazetted), Non-Ministerial Services, Recruitment and Promotion Rules, 2012, notified vide Notification of even number dated 29 -12-2012 .

**1. Short Title and Commencement.**—(1) These rules may be called the Himachal Pradesh Printing and Stationery Department, Assistant Section Holder (Composing), Class-III (Non-Gazetted), Non-Ministerial Services, Recruitment and Promotion (Ist Amendment) Rules, 2014.

(2) These rules shall come into force from the date of publication in the Rajpatra Himachal Pradesh.

“An official appointed on contract basis who has completed **three** years tenure at one place of posting will be eligible for transfer on need based basis, wherever required on administrative grounds” .

**3. Amendment of Annexure "B".**— In Annexure “B” of the said Rules, for the existing terms and condition No. 6 following shall be substituted, namely;

“An official appointed on contract basis who has completed three years tenure at one place of posting will be eligible for transfer on need based basis whenever required on administrative grounds” .
